

Stable and strong leader in him has left no stone unturned in managing the pandemic induced crisis and leading the country in arguably one of its most difficult times post-Independence.

THE SILVER LINING

- On exports and services fronts, the New Year could herald a new beginning of sorts
- Indian merchandise exports that were valued at \$27.58 Billion in September 2020 with a growth of 5.99 per cent over the same month previous year instil some hope
- Indian service providers that fought a valiant battle against COVID-19 propelled cancellation of orders have already moved into the positive zone with expansion reported in October 2020
- With COVID-19 related restrictions globally, scaled down service providers are bound to offer their best to the world

Every vulnerable section was given some relief or other from the three AatmaNirbhar packages and they would obviously continue to get support as the Prime Minister had reassured in various interactions with different sections of the society. From food grains to cash support, credit to subsidies, the Government has walked the talk as it moved about business like while remedying health disaster related adverse impact.

During six years of the Government, the way policies have been formulated keeping the welfare of poorer sections, all socially beneficial schemes, last mile deliveries with maximum transparency, corruption in high places negated, digitisation of public services ensuring that corruption at lower level was minimised. This surrealism is also reflected in independent consultancies' notes on India's economic growth prospects.

While challenges are many, this Government is known for turning most difficult situations into opportunities for making a mark on the global canvas like unfurling path-breaking reforms in labour and agriculture sectors.

These reforms were intended to bring about transformational change in the lives of New India's workforce and farmers. Four new Labour Codes and liberalised agricultural markets provide the perfect springboard to spreading prosperity to our hardworking industrial workforce and the farmers.

Without their participation, a healthy 3.6 per cent agriculture growth would not have been possible in the first half of this financial year. Similarly, the industrial growth that saw a downturn in April -September 2020, sprung back to life with 3.6 per cent growth in October 2020 thereby pointing to a firm manufacturing recovery going forward.

Backing prudent policies of the Government that seeks to be part of high value global supply chains could break the jinx in 2021. Trade surplus of \$17.74 Billion and exports at \$221.86 Billion achieved during April - September 2020 could be the perfect matrix to move forward. A NEW APPROACH TOWARDS YOUTH

- Starting from providing good education to the youth to ensuring that they get multiple options for shaping their future, the Government has come up with a range of schemes and programmes for them
- Startup India was launched to catalyse the startup culture in the country. It has helped in building a strong and inclusive ecosystem for innovation and entrepreneurship
- National Education Policy (NEP) was formed to create a young India with confidence, conviction and character. It has been ensured that the poorest of the poor get the right to better education according to their needs and convenience
- To help the poor youth belonging to the general category, 10 per cent reservation was given for the economically weaker section in education and government services
- Skill India Mission was launched to create convergence across sectors and States in terms of skill training activities. It seeks to provide the institutional capacity to train a minimum 40 Crore skilled individuals by 2022. Further to achieve the vision of Skilled India, the Mission would not only consolidate but would also coordinate skilling efforts to

- expedite decision making across sectors to achieve skilling with speed and standards
- National Skill Development Mission (NSDM) was launched in July 2015, to provide a strong institutional framework to implement and scale up skill development efforts across the country and to impart training to one Crore youth every year. For 2019-20, Rs 1,749.22 Crore was allocated for the scheme
- The Government has launched YuWaah a multi-stakeholder platform to make young people career ready. Under this, the young people will be given entrepreneurship classes (online and offline) with successful entrepreneurs and experts, towards establishing entrepreneurial mindset among young people
- National Career Service (NCS) was launched to offer jobs. As of December 2020, the portal has 1,02,74,899 active job seekers. A total of 81,158 employees were offered 71,024 vacancies till December 2020
- Make in India was launched to facilitate investment, foster innovation, enhance skill development, protect intellectual property and build best in class manufacturing infrastructure

THE JOURNEY AHEAD

- Starting from better education to improve income opportunity, the Government remains committed to the welfare of the youth. It is providing sufficient resources for the better health and nutrition of the youth
- The Government has formed five zonal committees to hunt sports talent across the country. One for each zone - north, south, east, west and north east. Committees will be formed under the Khelo India Programme of Sports Authority of India
- Several reforms brought into the traditional fields, including agriculture sector. With emerging possibilities, youth are now engaging themselves in these fields
- With the aim to transform poor rural youth into an economically independent and globally relevant workforce, Deen Dayal Upadhyaya Grameen Kaushalya Yojana was launched. Under this, the Government has aimed for training 28,82,677 youth by 2022. Till December 9, 10,80,900 youths were trained and 6,28,124 got placements

- Pradhan Mantri Mudra Yojana (PMMY) has been facilitating self-employment. Under PMMY collateral free loans upto Rs 10 Lakh are extended to micro/small business enterprises and to individuals to enable them to set up or expand their business activities

- Bank accounts of 22 Crore women were opened through Jan Dhan Yojana
- More than 7 Crore sanitary napkins were provided at Re 1 each from the Jan Aushadhi Kendra

FAST TRACK COURTS

Created a national data base to identify perpetrators against women, Around 1000 fast track courts are being set up across the country to hear such cases

New Dawn for women...

- Since 2014, several new laws introduced women empowerment
- For protection of girls, the Criminal Law (Amendment) bill was enacted. It provides death penalty for rape of a girl less than 12 years of age
- Law against Triple Talaq made the practice of 'instant divorce' a criminal offence. The compulsion of having a Mehram (male relative) was also removed for Haj pilgrims
- In every police station, a help desk was created for women. More than 600 One Stop Centres were also started
- To check cybercrime against women, a portal was launched. It was made compulsory for every

- taxi to have GPS and a panic button
- Women were allowed to work in night shifts and a permanent commission for women in the **Indian Armed Forces was allowed**
- More than 6.60 Crore women were added in different self-help groups
- Under the Pradhan Mantri Matri Vandana Yojana, a cash incentive of Rs 5,000 is being provided to pregnant women and lactating mothers for first living child. So far, 1.20 Crore women were given the amount
- Under Mission Indradhanush, 90 Lakh pregnant women have been vaccinated. Under Swachh Bharat Mission, toilets are being built in every household

New • The Government launched the National Repository of Information for Women (NARI) portal. It contains information about 350 Government schemes

- Beti Bachao, Beti Padhao, launched to address the declining Child Sex Ratio, is showing promising results. An improving trend is indicated in 104 districts
- Duration of paid maternity leaves for women employees is increased from 12 weeks to 26 weeks
 - The Centre is giving 8.1 per cent annual interest for saving accounts at post offices under the Sukanya Samriddhi Scheme for girls between 0 to 10 years

SMOKE-FREE KITCHEN FOR

ealth is wealth! And taking care of the health of women and environment is the biggest wealth creation that the Government is doing with the launch of Ujjwala Scheme. Under this scheme free LPG connections are given to BPL families. So far, over 8 Crore households were given free LPG connections through the Scheme covering around 98 per cent kitchens in the country.

DREAMS GETTING REALISED

- Pradhan Mantri Ujiwala Yojana (PMUY) was launched on May 1, 2016. The target to provide 8 Crore new LPG connections was achieved on September 7, 2019
- Around 98 per cent households are using LPG gas cylinders in their kitchens after the launch of Ujjwala which was just 55 per cent five years ago. There is an increase of 42 per cent
- Oil Marketing Companies (OMCs) have issued 1,306.87 Lakh LPG refills to PMUY beneficiaries under Pradhan Mantri Garib Kalyan Package (PMGKP) till August, 2020
- In 2016-17, 200.3 Lakh connections were provided. In 2017-18, 155.7 Lakh connections were given free of cost. In 2018-19, 362.9 Lakh LPG connections were released. In 2019-20. 82.64 Lakh connections were issued

NEW HOPE FOR BETTER FUTURE

- Now, the Government has raised the target of providing free LPG gas connection from 8 Crore to 10 Crore and for that provisions of Ujjwala are being changed. The Government has plans to provide LPG connections to all 28 Crore families of the country
- Under the Scheme, Rs 9,709.86 Crore was transferred directly into the bank accounts of Ujjwala beneficiaries during April-June 2020
- This is amongst the largest clean energy drives globally
- Steps are being taken to provide piped natural gas (PNG) and liquefied natural gas (LNG) to the poor families
- According to experts, having an open fire in the kitchen is like burning 400 cigarettes an hour





ndian Railways are being moulded into aspirations of New India and expectations of a Self-Reliant India. In the last six years, it has offered better safety, more cleanliness and has witnessed substantial improvement in reducing the travel time. A network of semi-high speed trains is being developed. Vande Bharat is an example of transformations taking place in Indian Railways. Taking Railways to the unserved areas, 100 per cent electrification of trains and zero carbon emission are Government's aims in the coming year

- Record 1,274 Manned Level Crossings were eliminated in 2019-20 compared to 631 in 2018-19
- Railways saw the highest- ever renewal of rails for 5,181 track km (TKM) in 2019-20 against 4,265 TKM in 2018-19. Total 505 pairs of trains were converted to Head on Generation (HOG), unleashing approximately 70 million litre diesel and Rs 450 Crore per annum potential saving
- In the field of green initiatives, a total number of 69,000 coaches were fitted with more than 2,44,000 bio-toilets in Indian Railways

- Railways have entrusted National High Speed Rail Corporation (NHSRCL) with the work of preparing detailed Project report for 865-km-long Delhi-Varanasi High Speed Rail corridor
- NHSRCL will be adopting Light Detection and Ranging Survey (LiDAR) technique using Laser-enabled equipment mounted on a helicopter for conducting ground survey
- Railways have aimed for electrification of the entire 28,143 kilometre of broad gauge by December, 2023. Around 66 per cent work was completed by November 2020
- The National Rail and Transportation Institute (NRTI), Vadodara, a deemed to be University established under the Railway Ministry, has announced seven new courses for the Academic year 2020-21
- It is offering Master of Sciences course in Systems Engineering in collaboration with the University of Birmingham, UK
- Railways are aiming for zero carbon emission by 2030. It will be installing Solar panels on the less used land
- Railways are fitting radio-frequency identification tags (RFID) in all wagons for tracking.

 Railways have announced recruiting 1.4 Lakh new vacancies

Even after seven decades of India's Independence, every household does not have the basic necessity of piped water supply. People have to walk miles for this very basic necessity. But since 2014, the Government has accorded top priority to assure basic services to the people living in the rural areas of the country to improve their living standards



Prime Minister Narendra Modi, in his address to the nation from the ramparts of the Red Fort on August, 15, 2019, announced Jal Jeevan Mission. While the Government was aiming for about 88,000 tap connections on a daily basis, currently about 1 Lakh households are being provided with tap connections daily. The Government launched a special mission mode campaign to provide potable piped water supply in all schools and Anganwadi Centres within 100 days

Fulfilling the dreams

Synchronisation of regional grids will help in optimal utilisation of scarce natural resources from resource-centric regions to load-centric regions. With more focus on renewable energy and Prime Minister Narendra Modi talking about 'One Sun, One World, One Grid', India having 36 per cent share of renewable energy is likely to emerge as the energy hub of the world

- With Pradhan Mantri Kisan Urja Suraksha Evam Utthaan Mahabhiyan (PM-KUSUM), uninterrupted power supply could be ensured in villages, which aims to install a total solar capacity of 25,750 MW by 2022
- India is the 4th largest in renewable power capacity and is growing at the fastest speed. The renewable energy capacity in India is currently 136 GW which is about 36 per cent of the total installed capacity



WONDER OF AYURVEDA

The importance of Ayurveda can also be gauged from the story of 8-year-old Mohd Musa from Afghanistan. In July 2015, Musa came from Afghanistan. His neck could not support itself. After several unsuccessful attempts to get treated from the costliest and the biggest hospitals in Afghanistan and India, his father Yusuf Naimi resorted to Ayurveda. Within just six months of Ayurvedic treatment, Musa who could not stand and walk for even two minutes was able to walk for around 6 to 8 minutes

EIGHT BRANCHES OF AYURVEDA

Ayurveda is complementary to Allopathy. While the latter provides an immediate relief, Avurveda works on weeding out the root cause of the disease. Ayurveda has been divided into eight branches from 1000 BC. It has medicine, child care, neurology, surgery, ENT-dental, toxicology, chemical medicine and traditional medicine. Every branch has different manuscripts with a detailed study. Apart from that, it has separate treatments for animals and vegetations. But the question remains why Ayurveda is lagging behind in India for so long despite being so vast? In 11th and 12th centuries, external aggressions dealt a blow to it and in 1835 under British rule, the Avurveda College in Kolkata was closed and was converted into a modern medical college. The Vaidyas (Ayurveda practitioners) were declared untrained. Britishers brought out a law making Allopathy mandatory excluding Ayurveda, Unani and Homeopathy medicine.

THE JOURNEY OF YOGA & AYURVEDA

Two decades after independence, Ayurveda and Unani practitioners got legal protection through a law in 1970. It was made a separate department in 1995 and renamed as Ayush in 2003 when Atal Bihari Vajpayee was the Prime Minister. However, Prime Minister Narendra Modi in 2014 made a separate Ministry of Ayush and brought international recognition to Yoga by advocating it at the United Nations (UN) on September 27, 2014. UN unanimously decided to observe June 21 as International Yoga Day



CHANGING FACE OF AYUSH

- There is a substantial increase in the number of Ayush colleges in the six years from 200 to 711
- Around 435 new Ayush opened hospitals are taking their numbers to 4035
- Nearly 1821 new dispensaries established between 2014 and 2018. There are now 27,951 Ayush dispensaries across the country
- Country has 8 Lakh Ayush practitioners now
- Around 18 Crore patients benefitted through Ayush facilities
- Country has 9,000 licensed Ayush shops

CORONA VACCINATION

- Scientists across the globe are working relentlessly towards realising their biggest goal - the Corona vaccine. In India, Serum Institute is working on Covishield, Bharat Biotech and ICMR are working on Covaccine and Zydus Cadilla is working on Zycov-D
- By January 2021, the nation will get its vaccine. The Government is getting ready for its transportation, storage and vaccination on a war scale. The entire campaign is under supervision of the Prime Minister
- National Vaccine Committee has prepared a blue print for it under the leadership of Dr V K Paul. Around 31 Crore people are being identified to get vaccinated from March to May, 2021

PRADHAN MANTRI JANAUSHADHI YOJANA

- Today, more than 6.600 Janaushadhi Centres in around 700 districts of the country are providing medicines to people which are 90 per cent cheaper than the market price
- These centres have 1,250 types of medicines and around 204 surgery equipment. These centres are also selling sanitary pads to women at Re 1 per pad

NEW HOPE

- This year the nation will have its own vaccine against Corona. The Government is geared up for vaccination programme
- The Government has accorded Yoga a status of competitive sports. This will encourage more people towards Yoga
- As per Khelo India Campaign, efforts are on
- to make Yoga an essential part of University Games. Around 51 medals are proposed for seven categories in four events of Yoga
- Janaushadhi centres will be opened up in almost all districts. The scheme of providing sanitary pads at Re 1 will be extended across the country



For seventeen-and-a-half centuries between 1 AD and 2000 AD, India's contribution to the world economy was one third but it barely managed to reach \$3 Trillion after seven decades of Independence. With certain measures taken by the Government, the country is on the path of becoming a \$5 Trillion economy soon. There is a substantial increase in the standard of living of common man due to economic reforms unleashed by the Government led by Prime Minister Narendra Modi, who took over the reins in 2014

ecisions such as pan-India uniform indirect taxation system i.e. Goods and Services Tax lowest (GST), Corporate Tax in 100 years, Insolvency and Bankruptcy Code (IBC), demonetisation to weed out black money, tax reforms and single window clearance for trade have made a huge impact on the Indian economy. This is evident from the rising graph of foreign investments and rise in the Ease of Doing Business Index ranking of India across the world.

The Prime Minister made a Clarian Call Jaan Hai To Jahan Hai when Corona pandemic hit the country and took decisions like imposing lockdown to deal with the menace. But, once the country was prepared to check the spread, he

INSOLVENCY AND BANKRUPTCY CODE (IBC): STRICT REDUCTION OF NPA ON DEBTORS

- When a debtor is unable to repay loan taken by him, loan is being declared as Non Performing Asset (NPA)
- Being unable to repay the debt by a businessman not only worsens the health of the banking system. but also weakens the economy. It is the Government's treasury which ultimately bears the losses of public sector banks and financial institutions
- To settle this issue. the Government implemented IBC in 2016 for the first time. Rate of NPAs got reduced by 9 per cent after this code
- India was at 137th rank in global resolving insolvency index in 2014. Now, the country is at 52nd rank

NEW DAWN

GST: ONE NATION, ONE TAX

- Goods and Services Tax (GST) was implemented as the 101st Constitutional Amendment. The Bill was passed by calling Parliament session at the midnight of June 30, 2017
- Before GST, tax rates lacked uniformity and were confusing and complex. GST is the most revolutionary step towards economic integration of the country
- Rates of tax levied were kept at four different rates of 5,12,18 and 28 per cent, ranging from essential items for life to luxury items. GST is proving to be a milestone in improving the overall investment climate in the country
- It is providing impetus to the Make in India campaign

DEMONETISATION: A REVOLUTIONARY STEP TOWARDS TRANSPARENCY

- Decision of demonetising currency taken on November 8, 2016, laid a strong foundation of making economy cashless. It is a revolutionary step towards a strong and transparent economy
- It resulted in the increase of number of IT returns from 4.04 Crore to 6.79 Crore
- Net direct tax collection increased from Rs 6,95,792 Crore in 2015 to Rs 10,50,678 Crore in 2020
- UPI transactions were Rs 6,952 Crore in 2016-17, which had crossed Rs 21 Lakh Crore in 2019-20. In November 2020 alone, the number crossed Rs 3.90 Lakh Crore
- Rise in the number of Corporate Tax returns from 8 Lakh in 2016 to 9.34 Lakh in 2019
- In November 2016, currency notes worth Rs 17.74 Lakh Crore were in circulation which increased to 22.35 Lakh Crore by December 2, 2019
- Income Tax department raids resulted in the recovery of Rs 3,950 Crore worth of undeclared assets from April 2017 till September 2020

EASE OF DOING BUSINESS: INDIA IS FORGING AHEAD

- As per World Bank report, India is now at 63rd position, with a jump of 14 places from 77th position last year. India's ranking was 142nd in 2014

- More than 40.38 Crore bank accounts have been opened so far. Out of this, 55.2 per cent account holders are women

Direct Benefit Transfer (DBT)

aranasi, the oldest city in the world, has some hidden treasure troves inside the city, but they all are lost in the concrete jungle. The initiative, planning and execution of Prime Minister Narendra Modi, who also happens to be the Member of Parliament from the city, have helped discover some real architectural marvels albeit in a dilapidated condition. These temples and other buildings were almost inaccessible due to encroachments. Kashi Vishwanath Corridor has not only given a new lease of life to over 63 ancient temples but has also given a facelift to Kashi Vishwanath Temple. In the past six years, the Government unleashed various changes and initiated various reforms all across. Some of the important decisions bore fruits when ranking of India in various global parameters went up cosiderably. Passport Seva Programme of Ministry of External Affairs (MEA) is one such Mission Mode

project under the National e-Governance Plan. issuance of passports is one of the most successful citizencentric activities of the MEA. In 2019, the MEA issued over one Crore passports. As a result of the increased capacity, the MEA was issuing 10 Lakh passports per month on an average before the COVID-19 pandemic struck the country. To enhance the security, Lotus, the national flower, is being imprinted on the passports. Prime Minister

Narendra Modi said: "Maybe the people who live abroad and those people who keep travelling abroad, they will know the respect that the Indian passport carries today. I don't think earlier anybody experienced the strength of the Indian passport."

- An applicant can apply for a passport from anywhere in India. Police verification would be conducted at the address mentioned in the form and the passport will also be dispatched at the same address
- mPassport Seva Mobile App was launched in 2018. enables applicants to apply, pay and schedule appointments for passport services. It also provides passport related information including PSK and POPSK location, fees, mode of submission and tracking of passport application status on smartphones
- The current provision allowing applicants to choose any appointment earliest date from the five available dates scheduling/rescheduling an appointment for passport related services
- Lotus, the national flower, has been imprinted on the passports as part of the enhanced security features to check fake passports

EASE OF TRAVEL RATING

 India improved its Ease of Travel rating by one place to 80th in the Henley Passport Index for 2019. It was ranked 81st last year and 88th in 2015 when e-visa was introduced for the first time. India's ranking in Global Passport Index stands at 48, which was 71 in 2019

EASE OF DOING BUSINESS RANKING

As per World Bank's annual report on the Ease of Doing Business (EODB), 2020, India ranks 63rd out of 190 countries. The ranking has moved up by 14 spots this year

WORLD DIGITAL COMPETITIVENESS RANKING

Improvement in terms of knowledge and future readiness to explore new technologies has helped india to jump four places to the 44th position in Digital Competitiveness Ranking in the world in IMD World Digital Competitiveness Ranking 2019. The report measures the capacity of 63 countries to adopt digital technologies as a key driver for economic transformation in businesses, governments and society

GLOBAL INNOVATION INDEX

 Innovation is a key to development and this is one of the guiding principles of the Government of India. India's Global Innovation Index 2020 rank is 48 among 131 economies, which is four positions up since 2019. India tops the list in innovation economies ranking in the Central and South Asia

WORLD COMPETITIVENESS RANKING

OLD LAWS SCRAPPED

- Successive Governments could remove just 1,301 obsolete laws which came in the way of smooth administration in 66 years, the present Government has managed to weed out as many as 1,500 laws in six years
- Article 370 and 35A of the Constitution that granted special status to Jammu & Kashmir are made inoperational. Despite nationwide protests, the Citizenship (Amendment) Act came into force on January 10, 2020
- The Government has computerised 16,845 district and subordinate courts and has released Rs 1,459.52 Crore for the implementation of the project. The project was approved in July 2015
- The Supreme Court has reportedly heard more than 15,000 matters through video conferencing since the lockdown was enforced on March 23. The Apex Court completed 100 days of virtual court hearings and disposed of approximately 4.300 cases till now. Around 1,022 benches were constituted to hear the cases and over 50,000 advocates appeared before the virtual courts
- From June 2020 to October 2020, 27 e-Lok Adalats were organised in 15 states wherein 4.83 Lakh cases were taken up and 2.51 Lakh cases were disposed of resulting in the settlement of Rs 1,409 Crore

he work culture of the country is changing with the focus on owning responsibility with transparency. To realise this objective, the Government has done away with many redundant archaic laws and has come up with new laws to make lives of people easy. Prime Minister Narendra Modi said, "In order to make a New India, we have been developing a transparent ecosystem in the country which is least dependant on the Government machinery. In order to achieve it, the rules have been simplified, and the laws have been amended if there was a need to amend them. And the laws have been repealed where there was a need to repeal them." The e-Committee of the Supreme Court is working towards ensuring justice at the doorsteps with the help of e-Chalan and virtual court.

NEW LAWS PASSED

- e-Committee of the Supreme Court has decided to give training to lawyers to argue court cases via video conferencing. Lawyers will get training for e-case filing and contesting cases in virtual courts
- Following the Centre's decision to scrap redundant laws as a model, Uttar Pradesh Chief Minister Yogi Aadityanath has made an announcement to prepare a proposal to scrap laws which are over 100-year-old
- Chairman of e-Committee of Supreme Court Justice D Y Chandrachood informed while virtually inaugurating an e-Court in Madras High Court that the Committee has taken the responsibility to ensure e-Service centre in every court of the country
- Under the e-Court project, 2,927 court premises of the country will be connected to high-speed Wide Area Network (WAN). Work is in progress in rest of the courts
- The number of e-Courts is being increased. There are two virtual courts in Delhi, two in Maharashtra, and one each in Haryana, Chennai, Karnataka, Kerala and Assam. Around 30 Lakh cases were disposed of ■




mpowerment of citizens started right from the start by the Narendra Modi Government when provisions of self-certifications were adopted in 2014. - 'One Nation, One Ration Card' (ONORC) provides an option to ration card holders/ beneficiaries covered under National Food Security Act to access their entitlements from anywhere in the country

GETTING READY FOR BETTER FUTURE

- NRA will give relief to poor candidates; benefit women candidates; and will prove to be a bonanza for candidates from rural areas. CET Score to be valid for three vears from the date of declaration of the result and there is no bar on number of attempts
- 'One Nation, One Ration Card' plan has been seamlessly enabled in an integrated cluster of 24 States/UTs w.e.f. August 1, 2020, covering approximately 65 Crore beneficiaries that is 80 per cent of the total NFSA population
- The Prime Minister says, "One Nation, One Election is not just a topic of discussion, but the necessity of India." There are some elections taking place somewhere in India every few months which affect developmental works. A thorough study and debate on 'One Nation, One Election' is on the cards



o achieve twin objectives of diversifying agriculture sector to double the income of farmers and making AatmaNirbhar Bharat a reality, Saffron cultivation is being extended to the North-Eastern region of the country.

Earlier, Saffron production was restricted to Pampore region of Jammu & Kashmir, which is commonly known as 'Saffron Bowl'. Budgam, Srinagar and Kishtwar are some other districts where Saffron is cultivated. Plants from seeds were transported from Kashmir to Sikkim and

were acclimatised in Yangyang village in southern part of Sikkim.

India produces 6-7 Tonnes of saffron while demand is for 100 Tonnes per annum. To meet the growing demand, the Ministry of Science and Technology, through the Department of Science and Technology (DST), decided to extend its cultivation to some states in the North East (Sikkim now, and later to Meghalaya and Arunachal Pradesh). There is a huge similarity of climate and geographical conditions between Kashmir and a few regions of the North East.

North East Centre For Technology Application and Reach (NECTAR), an autonomous body under the DST in collaboration with the Botany and Horticulture departments of Sikkim Central University implemented a pilot project in Yangyang village of south Sikkim.

The university department carried out tests to understand the soil and actual pH conditions of Yangyang and found it comparable to saffron growing places of Kashmir. Saffron seed/corms were air transported from Kashmir to Yangyang

> site by the department. One saffron grower was engaged and stationed to look after the complete growing process, along with the university faculty.

> The corms were irrigated during the months September and October, which ensured timely corm sprouting and good flower yields. Similar climatic and geographical conditions in Pampore (Kashmir) Yangyang (Sikkim) led to the successful sample farming of saffron in Yangyang. ■




